Google Apps – Provides access to the school laptops. Also gives children secure email accounts and tools to support the whole curriculum.
MicroLibrarian – This software is used to track the books that are being taken out of our library and read by the children.
Education City – A range of games to support Maths, English and Science.
Sumdog – Maths games to support the maths curriculum.
Times Table Rockstars – Games aimed at improving times table knowledge.
Spelling Shed – Games aimed at improving the children's spelling ability.
Accelerated Reader – This software is used to support reading comprehension.
Purple Mash – A range of tools to support the whole curriculum.
Class Dojo – A tool used for rewarding children's learning and positive behaviour.
